MINUTES OF SPECIAL MEETING WOODLANDS WINDING BROOK HOMEOWNERS ASSOCIATION, INC. THURSDAY, MAY 11, 2023 7:00 P.M. AT SHERWOOD OAKS CHRISTIAN CHURCH

1. Welcome from presiding board member Valerie Grim and explanation of the items on the agenda for tonight.

At large board member Valerie Grim Presided over the meeting and explained the meeting agenda before starting. The petition, responses to the petition, meeting notice and proxy forms had been mailed by USPS to all homeowners three weeks prior to the meeting.

6. Voting

Valerie Grim explained the rules for voting. There will be a 10-minute break. During the break, each homeowner would get a ballot from Tonya with Jamar (who would check them off the homeowner list for verification purposes). The homeowner would then put their confidential ballot into the ballot box faced down. The homeowners may then also put any proxy votes they have into the ballot box (votes are indicated directly on the proxies). During this break, homeowners may call their proxies to confer with what they want their proxy vote to be. A disability accommodation request was honored by allowing a hybrid style meeting where homeowners could attend, listen, and publicly comment either in-person or by Zoom.

In the presence of all attendees, there were three independent counts of the votes for comparison by:

- 1. Board member, Shahana Ansari
- 2. Legal counsel, Jason McAuley
- 3. Property Management Jamar, Tonya Miles

Voting tabulations

26 to 22, in favor of retaining Aran Mordoh to the board

25 to 22, in favor of retaining Shelley Taylor to the board

Pursuant to Article XI, Section 1 of the By-Laws, "A member shall be deemed in good standing and entitled to vote at any annual or at a special meeting of members within the meaning of these By-Laws, if, and only if, he shall have fully paid all assessments made or levied against him and the unit owned by him." There were seven (7) ballots cast by homeowners with assessments that were past due as of May 11, 2023. Those seven (7) ballots were not included in the tabulation of votes. Legal counsel, Jason McAuley, and Tonya Myles from Jamar Property Management, will send emails to these seven (7) homeowners on May 12, 2023, to advise them that because of their past due assessment balance, their ballots were not included in the tabulation of votes.

Board member, Valerie Grim announced the results of the vote to attendees, that Aran Mordoh be retained as a board member, and that Shelley Taylor be retained as a board member.

The voting tabulations and ballots were kept by Jason McAuley with McAuley Law LLC to be scanned and sealed and then delivered to the financial manager to be stored until such time (two years from now) when the financial documents and votes are moved to the board secure locked storage area. The votes will remain sealed unless they are required to be opened for legal cause.

Since there was no vote to remove, no nominations or election was necessary.
